## 4 FIRST AID MEASURES

**Inhalation:** Move injured person into fresh air and keep person calm under observation. Get medical attention if discomfort persists.

## 5 FIRE-FIGHTING MEASURES

**Extinguishing Media:** Extinguish with foam, carbon dioxide or dry powder.
